## PROCESSING GUIDELINES

1. All visitors requesting installation access are subject to criminal history checks prior to approval for base access. Non-approvals due to errors in state or local police records **MUST** be addressed by the visitor with the appropriate agency. Visitors wanting reconsideration must provide their sponsor with documented proof of correction and bring it to 37 SFS/S5L, Bldg 5616, Lackland AFB, TX. The information provided will be reviewed and their request for a base access pass will be reevaluated. Visitors must be informed that he/she must have current proof of insurance, proof of registration and a current/valid driver's license. While on this installation all personnel and the property under their control is subject to search.
2. Sponsor must hand carry the list to the 37 SFS/Police Services section in Bldg 5616.
3. The list must be received by Police Services section **NLT 10 duty days** (business days) prior to date of visit.
4. Please ensure the list has the requested information as listed above. Any list not having all the required information will be not be accepted.
5. If you have a government email account you can digitally sign/encrypt documents through that account, we will accept emailed guest list at "37SFS.Police [ServiceS5L@LACKLAND.AF.MIL](mailto:ServiceS5L@LACKLAND.AF.MIL)"
6. Visitors will only be allowed to entry the installation through either the Airman's Gate (410 @ Valley Hi Drive) or Gateway East Gate (S.W. Military @ Luke Blvd) NO EXCEPTIONS.
7. If you have any further questions, please call us at 671-2273.
8. Sponsor must ensure that their guest(s) are aware that at all times while on the installation they and their belongs are subject to search. Guest must stay with their sponsors and not enter and areas marked "Controlled" or "Restricted".
9. **CONCEALED CARRY LICENSE HOLDERS ARE PROHIBATED FROM BRINGING FIREARMS ON THE INSTALLATION.**
